Investment and Return Objective

The investment objective of the Fund is to provide an attractive total return to investors, applying a conservative income focussed investment style and targeting capital preservation.

Investment Process

To achieve this objective, the fund will be investing primarily through global collective investment schemes (and / or directly) in a diversified portfolio of predominantly defensive assets, such as government fixed income securities and investment grade corporate fixed income securities. The fund will also allocate limited exposure to growth assets such as equities, high yield fixed income securities, emerging market fixed income securities as well as real assets. The Fund may use financial derivative instruments for efficient portfolio management purposes and hedging.

There is no geographic or sectoral bias intended and the Fund will have exposure to both developed and emerging markets.

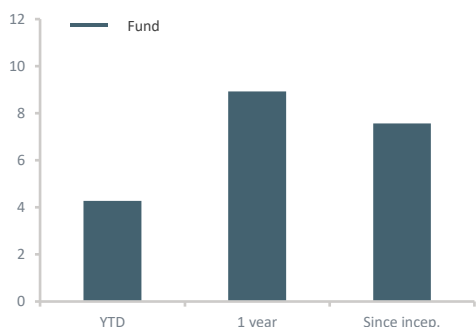
Suitable Investors

RISK INDICATOR

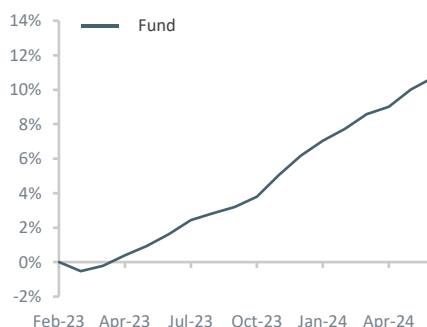


ANNUALISED PERFORMANCE (%)

FUND COMMENTARY

The fund performed reasonably over the quarter. The quarter was characterized as a tale of two extremes, starting with a bond and equity sell off in April 2024 in the USA, that flowed through to global markets. The sell off was triggered by positive (upside) US inflation surprises, driving then notion "higher for longer" via the FED Fund Futures as the market toned down the future Fed Funds Rate cuts. This sentiment was extrapolated to longer maturities and other risky assets.

The sell off was followed by a volatile, but stronger bond and equity performance in May - and June 2024 in the USA. Equities were mostly driven by Information Technology, Consumer Discretionary (Amazon) and Consumer Services (Alphabet Inc) in the US (magnificent seven), even as US growth expectation softened.

European bond and equity markets trended sideways post the April 2024 sell off and started to weaken when the French President Emmanuel Macron announced an early legislative election on June the 9th. The strength in support for non-centrist parties notably the far-right National Rally (Marine Le Pen) spooked the market. The final election results, where no one got an outright majority, sets up a political gridlock that's likely to haunt both France's markets and the overall outlook for Europe.

In the currency markets the US Dollar Index, the DXY representing the US Dollar to a basket of foreign currencies, has traded in a volatile sideways channel. The most notable mover in the currency market was the Japanese Yen ("JPY"). The JPY hit fresh highs against the US Dollar in June after a continues sell off mainly driven by the large interest rate differential to major economies.

The Bloomberg Commodity Index was flat over the quarter, with dispersion on underlying indices. The Bloomberg Industrial Metals Subindex and Bloomberg Precious Metals Subindex had a strong quarter, up 8.3% and 6.5%. Bloomberg Petroleum Subindex and Bloomberg Grains Subindex had negative performance, 1.3% and 7%.

The fund was conservatively position at the start of the quarter preferring to receive the carry by having an overweight allocation to high quality short duration fixed income assets. A small allocation to growth assets was built over the quarter.

Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (% PF (%): The Performance Fee is a payment made to the Fund Manager for generating positive returns and is generally calculated as percentage of investment profits, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Fund Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
