

# TBI Global Multi-Asset Income Fund

Minimum Disclosure Document & General Investor Report - Class A

## Investment and Return Objective

The investment objective of the Fund is to provide an attractive total return to investors, applying a conservative income focussed investment style and targeting capital preservation.

## Investment Process

To achieve this objective, the fund will be investing primarily through global collective investment schemes (and / or directly) in a diversified portfolio of predominantly defensive assets, such as government fixed income securities and investment grade corporate fixed income securities. The fund will also allocate limited exposure to growth assets such as equities, high yield fixed income securities, emerging market fixed income securities as well as real assets. The Fund may use financial derivative instruments for efficient portfolio management purposes and hedging.

There is no geographic or sectoral bias intended and the Fund will have exposure to both developed and emerging markets.

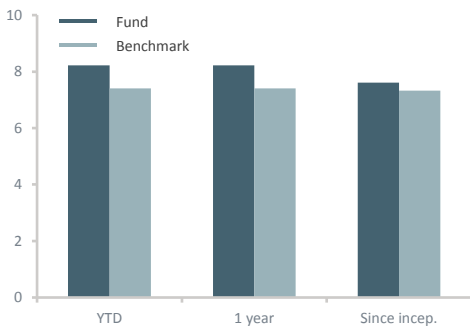
## Suitable Investors

## RISK INDICATOR

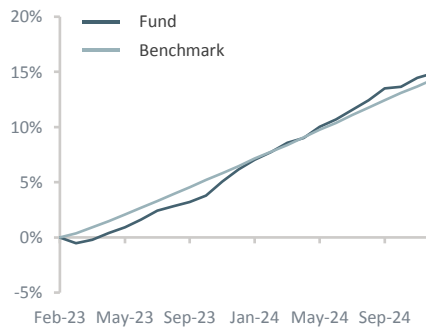


### ANNUALISED PERFORMANCE (%)

## FUND COMMENTARY

Over the final quarter of 2024 the global macro environment was very divergent with the USA maintaining above trend growth supported by consumer spending. The outcome of the US election settled some concerns on fiscal policy but uncertainty will remain high and will be reflected in expected asset risk premia. The softening trend of US inflation is losing steam hovering just below 3%. This is restraining the FED's willingness to reduce short term interest rates by much more.

The Euro Area deteriorated over the final quarter of 2024 with soft retail sales and negative industrial production year on year prints in both October 24 and November 24. Inflation remains under control and with the soft growth prospects will allow the ECB to maintain the rate-cutting cycle.

China appears to be waking up, although growth has been hampered by a very negative consumer and a structurally weak property market. Authorities have been adding stimulus to the system but seem to be talking more than actual substantive actions. It seems like authorities want a better grip on potential US trade actions to formulate stimulus strategy.

The fund had a disappointing quarter from a performance point of view. Both October and December 2024 under performed in a market that allowed for little place to hide. In the market, US curves sold off with limited opportunity in credit. The short duration ( up to 2 years) government bonds in the Euro Area had limited, but positive returns with some value add in credit. Equities had a negative quarter except for the Nasdaq 100.

On fund asset level the defensive position allowed for some carry to defend and avoiding draw downs. Equities detracted whilst fixed income and FX carry contributed positively. Both the global credit and European high yield exposure had a positive quarter.

## Glossary

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Total Expense Ratio (TER%):** The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

**Performance fee incl. in TER (%) PF (%):** The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

**Transaction Costs (TC%):** The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

**Total Investment Charges TIC (%) = TER (%) + TC (%):** The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

## Fund Specific Risk
