Fund Objective

The objective of this fund of funds portfolio is to offer a low risk, liquid investment which will generate returns predominantly in the form of dividends and capital growth. The total return of the fund will aim to exceed the average after-tax yield normally received from money market portfolios.

Fund Strategy

This unit trust has a conservative investment mandate that will follow a risk profile focused on capital preservation.

The fund invests in a spectrum of collective investment scheme portfolios investing in non-equity preference shares, other non-equity securities (including money market instruments, bonds, debenture stock and debenture bonds and notes) as well as the equity and real estate markets, offering a low-risk return.

The fund may have an effective equity exposure of up to 5% and a maximum effective property exposure of up to 15% (including international assets). The fund may also invest in listed and unlisted financial instruments for the sole purpose of hedging exchange rate risk.. The fund focuses on capital preservation and on enhancing the after-tax returns for investors to provide a higher total after-tax return than enhanced cash funds.

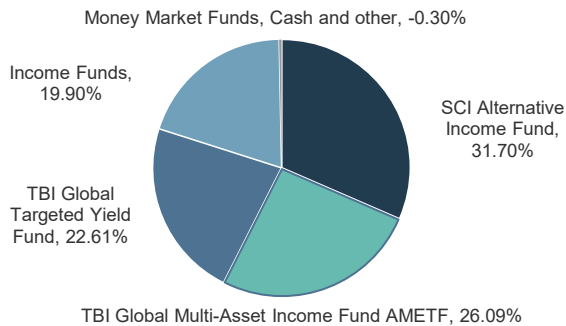
